

The meeting was called to order by President, Brad Blair at 1:08pm following a potluck dinner. Pastor Bob led the gathered in an opening service of Dialogue & Prayer to celebrate who we are as a Church.

Agenda: Motion to approve, with the addition of an introduction of Daniel Schewe whom we will be considering for call as Associate Pastor, by Neil Sendler, 2<sup>nd</sup> by Doug Haneline, passed.

Minutes of January 18, 2015 Annual meeting minutes: Motion to approve by Dan Babin, 2<sup>nd</sup> by Gloria Vonder Heide, passed.

**Appointment of Tellers:** Jim Coates, Neil Sendler, Brenda Heacock. Counted 104 voting members present, which exceeds the quorum required for the meeting to take place.

**Nominating Committee:** Outgoing council member Mikaela Bradley was recognized as having served the first position of youth representative to Congregation Council. Michael Mulligan was also recognized for his service on council. Floor was open to nominations, but none made. **Motion to approve nominated slate of candidates for congregation council** by Peter McKinney, 2<sup>nd</sup> by Ted Niemeyer, passed.

**Special recognition was given to member Elaine Rongey** for instituting and working for 11 years on the Fair Trade ministry at TLC.

Review of Reports – Pastors, President, Staff & Committee Reports: Motion to receive Dan Babin, 2<sup>nd</sup> by Kim Engle, passed. Mention was made of need for more sacristans and invitation was extended for volunteers.

**Treasurer's Report & Presentation of 2016 Budget:** Motion to approve by Jim Coates, 2<sup>nd</sup> Dave Johnson, passed.

Notes from Treasurer Basher: Christian Education budget is lighter because of 2015 training that is not being repeated in 2016; Youth budget is higher because we are paying for adult chaperones on the mission trip; Property budget is affected by the hiring of a cleaning service and part time sexton that replaced a full time sexton and also the cleaning of the lantern, which wasn't done in the past; refunds are expected on leases on office equipment that were overpaid; the Day Care Center was closed in the Fall of 2015; Payroll is affected by moving the sexton's salary into a different budget line to pay the cleaning service; Stephen Ministry will be paying for training additional members and supervisors in 2016. Other notes were on the debt repayment for the parking lot (30 year loan with 5 year balloon); new associate pastor's salary (in line with Synod's compensation and benefits guidelines); 2016 pledge expectations based on 2015 receipts versus pledges. He also noted that salaries are now 57% of budget, down from 63% previously.

#### **New Business:**

#### **Call Committee Report:**

TLC formed a call committee in September, 2015, chaired by Rachele Battreal for the Associate Pastor position. The committee was diverse across gender, age and four worship services: Dawn Brackmann, Dan Butler, Curtis Hahn, Allie Radke, Nick Zientarski and Brad Blair, ex officio as Council President. They met a dozen times from October through December.

Rachele presented Dan Schewe for consideration for call to the associate pastor position at TLC. She noted that he was the only candidate considered since he was assigned to our Synod and the Bishop felt this would be a good match for us. The Call Committee took extra steps to ensure that he met the needs identified in our Ministry Site Profile including interviewing extra references. Other due diligence steps included meeting with Dan multiple times, going to hear him preach and lead worship at Zion Lutheran in Comstock Park, reading his blogs and other writings. The congregation will have the opportunity to vote on the call at a specially called meeting January 31 following 11:15 worship. We viewed a video introduction of Dan, his wife Alexis and son Sam.

#### Proposal for a Capital Campaign.

John Fox presented a proposal by the Capital Campaign Committee for consideration.

I present a motion to spend \$60,000 plus expenses not to exceed \$20,000 to hire Walsh and Associates to conduct pacesetter and capital campaigns during 2016 for the purpose of securing pledges for the Trinity Lutheran Church building campaign.

He described the process as organizing face to face solicitations and handling the promotions since the congregation survey determined that we do not have the volunteers or experience to perform this function without assistance. In addition, to obtain a construction loan, we will be required to have a professional company do this. The timeline might be: pace setter campaign in the spring and capital campaign in the fall for the three year cycle. **Motion by Jo Murphy,** 2<sup>nd</sup> by Peter McKinney/ passed.

**Announcements:** Pastor Bob announced plans for Lent in 2016. The congregation expressed thanks to Pastor Jonathan Reid for his interim ministry at TLC.

**Motion to adjourn** by Michael Mason, 2<sup>nd</sup> by Beth Engstrom, passed.

Closed with the Lord's Prayer and Doxology.



Dear Fellow Ministers of Trinity,

For everything there is a season, and a time for every matter under heaven . . .

What gain have the workers from their toil? I have seen the business that God has given to everyone to be busy with. He has made everything suitable for its time . . .

Ecclesiastes 3

The wisdom of Ecclesiastes gives us reflection, song and a sense of vocation, as we contemplate the 'business' or the 'busyness' that "God has given to everyone to be busy with." Our life together can certainly be characterized as busy among the people and through the programs of Trinity, but it is a busyness that is rich in mission and ministry.

I have the privilege of sharing a few of the highlights of my fourth year among you as Trinity's Senior Pastor in this report. In the spirit of 'for everything a season,' I will offer that report in the context of the four seasons of 2016.

#### **WINTER 2016**

The Annual Meeting of the Congregation in January included the adoption of a strong budget, the election of leaders and action to take on a Capital Campaign with consultants from Walsh and Associates. We also began to seek the contractors that would lead our Cross Tower remediation project, after authorizing that major initiative in December of 2015. I led a new pastor's class on Wednesdays with subject material from Mark Stenberg's 51% Christian; Finding Faith after Certainty. In the absence of an Associate Pastor I continued teaching the Sunday afternoon Confirmation classes and sought to support those who were leading ministries with Middle School and High School youth, including planning for the summer of 2016 Mission Trip and the turnout of campers for Stony Lake. I had a leadership role in a major event, "Welcoming Refuges: Do Unto Others," at the Catholic Information Center in March with more than 400 community members in attendance. We celebrated together another Kids Against Hunger meal packing event in February and responded with cash offerings and bottled water for the people of Flint through our partners at Salem Lutheran Church in that community. The Outreach ministry of our congregation reported on 2015 benevolent giving in excess of \$230,000 through wider church and community partnerships. The people of Trinity began our Lenten journey to Easter with midweek worship, soup suppers and devotional resources, culminating with our Holy Week worship gatherings. A first (annual?) Holy Week Seder Supper was held with an enthusiastic gathering and a wonderful meal. The Trinity Travelers continued their preparations for the "Walking in the Steps of Martin Luther" Germany tour in the summer of 2016. And after a half year of vacancy, Pastor Dan Schewe received and accepted the call to join us as Associate Pastor on January 31. His arrival in February marked the beginning of a new chapter of pastoral ministry at Trinity. Pastor Dan was ordained and installed into the Ministry or Word and Sacrament on March 19.

#### **SPRING 2016**

A \$50,000 anonymous gift seeded a new Building Endowment Fund at Trinity as a matching grant challenge – the people of Trinity responded and more than \$165,000 is now working as a 'forever gift' to provide future care and maintenance of our facilities and grounds. Eighteen fifth graders completed a multi-week communion class with me and received Study Bibles for their Confirmation years at Trinity. We began to assemble a New Members 'class' for the spring and by early June we had received 50 new adults and children into our life together. Preparations for Art and Music Camp, SpringHIII Day Camps, Camp VBS and Stony Lake Camp continued and Pastor Dan climbed into the saddle as our Youth and Family Pastor as the Mission Trip youth continued to plan their summer week of service. JOYful Days participants and Rummage Sale volunteers filled Centennial Hall and a Master Plan Revision from our architects rolled back the \$9 million original plan to a \$5 million alternative, a plan many perceived as superior to the larger plan completed the year before. That plan was shared in after worship forums in early May and was well

received by the congregation. I led a new Wednesday pastor's class based on Lisa Miller's text "Heaven; Our Enduring Fascination with the Afterlife." With the conclusion of Tim Van Der Bilt's five years of staffing Trinity's children's ministries, job postings for part-time Youth and Family staff positions were followed by a series of May and June interviews, culminating with the hiring of six part-time Children, Youth and Family staff members. A beautiful new Paschal Candle stand was dedicated to the memory of Pastor David Paul in the church sanctuary and the Trinity Choir began to sit in new posture chairs in rehearsal.

#### **SUMMER 2016**

A highlight of my summer was joining the 26 "Trinity Travelers" for eleven days following Martin Luther's heritage across eastern Germany. On the home front, working closely with Pastor Dan and our new Children, Youth and Family staff, we celebrated a strong start in fall programming for Trinity's families with children. A successful series of camps and Mission Trip were facilitated by our new staff and great volunteers. The Outdoor Worship service in July moved indoors as the rain came but the accompanying Pig Roast was a well-received new food and fellowship event. The "Strengthen to Serve" Capital Campaign kicked off in the early summer with its Pacesetting phase and a very strong team of leaders stepped up to facilitate this significant appeal. Cross Tower remediation continued with complications due to more severe damage than expected when the stone was exposed and structural damage that had to be addressed.

#### **FALL 2016**

A six-month capital campaign effort culminated in pledges and gifts for our building project totaling more than \$3,760,000. Sunday School and fall programming unfolded with new energy and growing participation. Trinity began its observance of the 500<sup>th</sup> year of the Reformation with a wonderful community Hymn Festival on Reformation Sunday and a series of monthly columns in our newsletter from the Trinity Travelers home from Luther's Germany. I continued to teach my Wednesday morning and evening forums and added in some First Communion classes for younger Trinity members. 21 ninth graders were lifted up in a festival Confirmation Sunday celebration and another 30 adults and children were received into membership, marking 90 new members in 2016. The people of Trinity embraced a new partnership with Congress Elementary School and the welcoming and resettlement of a new Congolese refugee family. Nine Trinity members who had died were lifted up on All Saints Sunday and 20 newly baptized in the last year were blessed. We came to yearend with a meaningful journey through Advent to Christmas, punctuated by a grace-filled first offering of a Children's Christmas Program by our new Youth and Family staff.

A new season is upon us as we gather in Annual Meeting in January of 2017. We embrace the revelation of a God who "makes all things new" in Christ Jesus, and the privilege of a new year of mission and ministry together. I am grateful to be a partner along the way. Grace and peace to you all.

My summer was highlighted by two trips and a wonderful week of Vacation Bible School.

Our Vacation Bible School was more targeted to the early elementary youth of our congregation and community, and was by all accounts a great success. I continue to thank Beth Hall for all of her work making it so. This summer we are trying out an evening VBS with activities for the whole congregational family.

It was a joy to spend a week in July with over forty of our youth at Stony Lake Camp. We laughed, played, and got to know each better all while learning more about how God was calling us to live. I am eager to continue to strengthen our partnership with Living Water Ministries, the organization that runs Stony Lake Camp. They are doing amazing things across Michigan, and beyond, to help raise up leaders and fight injustices.

In June I was blessed to spend a week with twenty-nine youth and eight adults in Somerville, Tennessee. We helped renovate homes for residents of that area and share with the what God has done for each of us. I continue to thank all the chaperones, parents, volunteers, and fund raising coordinators. This life changing experience was possible only through the generous support of Trinity through all of the fund raising efforts. I am excited for this summer's trip to Norris town Pennsylvania. We already have thirty-eight youth confirmed for the trip.

This September it was my joy to start teaching Confirmation classes as the primary instructor to our middle school youth. We have had a joy learning more about the Reformation, Luther, and what it means to be Lutheran. We will finish out this year studying the Gospels and Sacraments.

It has been a great honor to meet and spend time with a number of our members in their own homes, hospitals, and rehabilitation facilities. I find joy in the times we have shared stories, communion, and prayer. I am thankful for the friendships that have formed through these visits.

I continue to love worshiping at all of our services as we express our adoration to God for all He has done for us. I am thankful for the assistance of Larry Biser in helping me with my canting.

In addition to all of these amazing activities Trinity also embarked on a new staffing paradigm to serve our children, youth, and families. Our new configuration allows us to have gifted individuals focused on smaller ministry profiles to better serve those groups. Brittany Fischer is our Children's Ministry Coordinator. She is focused on making our Sunday School program a place where our children can learn the faith and build community. This year we started a new curriculum and a new start time. James Morin serves as our Family Activities Coordinator. He oversees activities for families such as Trunk or Treat, which went incredibly well this year. Taylor Sytsma is serving as our Middle School Ministry Coordinator. She has proven to be an amazing asset to our Confirmation program and is helping strengthen the community of our middle schoolers. Ashlee Wetherington serves as our High School Ministry Coordinator. Her energy and passion for helping our senior high youth find grounding and expression to their faith is contagious. Rachele Battreall serves as our Director of Youth and Family Ministry. In this role she is helping highlight different development moments in the lives of our children and families such as the blessing of the backpacks, gifting and connecting with newly baptized member families, and helping reach out to our youngest families. She also helps coordinate efforts across the whole children, youth, and family ministry team.

I know that over these past ten months I have been blessed by the people of Trinity, and have witnessed how you have been a blessing to the greater Grand Rapids community. I look forward to the ministry God continues to lead us into.

A year ago I mentioned in my January message that I am overjoyed and sometimes overwhelmed by how active our Congregation here at Trinity is. This remains true as we begin 2017 together and say goodbye to 2016. Here are just a few of the highlights of the year just completed:

- Welcomed a new Associate Pastor in Dan Schewe, his wife (Alexis), son (Sam) and recent addition Benjamin Herb.
- Revamped our Children's and Youth & Family Ministry team and programming including hiring part time staff members:

Rachelle Battreall - Director of Youth & Family Ministry

Brittany Fischer - Children's Ministry Coordinator

James Morin - Family Activity Coordinator

Taylor Sytsma – Middle School Ministry Coordinator

Ashley Wetherington - High School Ministry Coordinator (added to her existing Finance Assistant duties)

- Conducted and completed a six-month Capital Campaign that received 3-year pledges to date totaling \$3,745,275 for the purposes of renovating, remodeling and refurbishing our 60+ year old building.
- Provided initial capitalization through congregational gifts to our Building Endowment Fund of nearly \$170,000 which will allow
  us to begin using the interest gained on this fund to perform building repairs outside of our annual budgeting for property
  management.
- Approved funding for the remediation of our iconic Cross Tower and, hopefully, will have completed this work by the time you read this.
- Welcomed 80 new members in Spring and Fall celebrations
- Established a "Call Committee" which has unanimously recommended the hiring of Karen Niemeyer as a part time "Assisting
  Pastor" to help provide any or all of the following: pastoral care and visitations, worship leadership, recruiting & equipping
  leaders, senior ministry and volunteer recruitment.

And did all of the above while running a surplus in our Annual Budget giving allowing us to increase our benevolent gifting.

As we move into 2017 our building will remain a major focus area as we determine what we will do which will be derived from whether and how much we choose to supplement our 3 year "Strengthen to Serve" pledges with additional borrowing. Many meetings with Architects, construction management and hours of reviewing costs and alternatives will take place early in 2017 in the hopes of bringing alternative plans to the congregation for a "go forward" decision. Lots and lots of work ahead!

As we begin this New Year I continue to request your prayers for God's strength and guidance and for His will to be done through the good men and women serving as your Congregation Council members.

As part of Trinity's 2016 budget, a total of \$33,900.00 was approved for benevolence. That total has been distributed on a quarterly basis to 17 organizations over the past year.

Trinity's budgeted benevolence was distributed using a percentage formula. On the left is a summary of some of the gifts that Trinity has been blessed to distribute.

Please keep in mind that, since our fiscal year does not end until January 31, this is a preliminary report. The complete report will appear in the March edition of the *Messenger*.

\* Trinity had been supporting Pastor Ann Klavano in Papua New Guinea for a few years but her term ended there in the spring of 2016. She was the recipient of our 1<sup>st</sup> quarter benevolence distribution for ELCA Missionary Support.

After consideration by the Outreach Committee, the remaining fiscal year benevolence dollars for that line item have been distributed to Mission India in Neerekshe.

The Children's Ministry Committee works with ministry and programs that involve our youth from birth through 5<sup>th</sup> grade. A HUGE thank you to all church members who have volunteered as teachers and in other ways. None of these things could happen without you!

Thank you to the following members who have served on this committee for all or a portion of the year: Rachele Battreall, Beth Hall, Brittany Fischer, Kris Shannon Elizabeth Derbin, Kathy Bush (council liaison), Chris Becker, Kristine Lang and Amy Stephan (chairperson). We are looking for a few people to join the committee, especially if you have a kindergarten or younger age child. Please contact Pastor Bob, Pastor Dan or Amy Stephan if interested.

2016 has been a year of change within our committee and the ministries/programming being offered to the children of Trinity. One big change was in staffing. The full time Children's Ministry position was restructured and interviews happened between the end of April and mid-June. After much consideration and interviewing, the gifts of the following Trinity members stood out and they were hired into part time roles:

Rachele Battreall – Director of Youth and Family Ministry Brittany Fischer – Children's Ministry Coordinator James Morin – Family Activities Coordinator Awilda Diaz – Nursery Coordinator

Another change was with Sunday morning education. In September, teachers started using a new curriculum which is Lectionary based. It follows the church calendar so the children are learning about the same bible stories that are being read in the Sunday morning services. The structure of Sunday mornings now allows children who attend the 10:00 service to start by worshiping with their families, be a part of the children's sermon and then head to Sunday School. We are averaging 50 kids each week. Come join us and see what it is all about! We welcome feedback as we try to provide a strong and faith filled Sunday morning for our kids. Parents, please share your thoughts on the changes with Brittany Fischer, either pastor or any committee member.

#### Key events this year have included:

**Roller Skating** – A fun family event in January.

**Kids Against Hunger Meal Packing** – This took place in February and was a multi-generational activity. Over 15,000 meals were packed!

Winter Service Project – Children brought in personal care items as part of their offerings that were then donated to local agencies.

**Art and Music Camp** – Held the beginning of June for 2<sup>nd</sup> – 8<sup>th</sup> graders.

Spring Hill Day Camp – Hosted at the end of June, staffed by Spring Hill and open to the community.

**Vacation Bible School (VBS)** – Beth Hall stepped up to plan and lead this traditional event as we were in transition during the planning stages. Over 100 children from Trinity and our community participated.

**Rally Sunday** – A fall kickoff of our Sunday School year with 53 kids participating. Balloon animals, pictures and snacks were part of the fun as kids explored their classrooms and got registered for the fall.

**Trunk or Treat** – About 300 people attended the fun evening of games, food, decorated cars and "trunk" or treating. **Christmas Pageant** – More than 40 Children were involved in the December 18<sup>th</sup> service as they sang and told the Christmas Story.

We look forward to our children learning more about God's love and grace as they participate in both Sunday School and other events in 2017.

daughters Anna and Eleana. The speaker and musician set the mood and helped the attendees prepare for the coming of the Christ child.



Angels of Advent Tea: Again this year we had a spectacular response to our Angels of Advent Tea. The planning team of Kristen and Abigail Lamprich, Joanna and Sydney Waite and Rochelle Roskam and Arabella Soule chose and implemented several crafts and take away's including a votive candle with a battery operated candle that changes colors for the afternoon. We had 30



mothers/grandmothers and 34 young ladies age 3-12 R.S.V.P. to attend. The afternoon was filled with a time of fellowship, fun and food. As always the chocolate fountain was hit, we had milk and dark chocolate and the new addition of tea sandwiches was enjoyed too. We had a great turn out despite the weather.



<u>Celebration of Service:</u> The third Sunday in January where we lift up the volunteers who have served our church family and community over the past year. We come together after the late service filling Centennial Hall for our all church family potluck. Lutherans love to eat! Once the meal is finished we address the



business of our church at our annual meeting, such as election of council members, delegates to Synod Assembly, changes to the constitution and any other business which this year included the recommendation of Pastor Dan Schewe to serve as our next Associate Pastor.



<u>Dinner Groups</u>: This year our numbers were down slightly, however, we had several new couples participate as well as a prospective couple. These three opportunities to gather with other members of our church family for an evening of food and fellowship

<u>Helping Hands</u>: The Helping Hands Meal program has once again increased the number of families and meals we have provided to members in need. Finding rides for our beloved elderly members and others with special needs ride requests continue to go unmet. In 2016, we served approximately 15 families which were over 375 meals provided Trinity members.



#### Homebound Ministry (Bulletin Mailing and DVD's):

We continue to send bulletins weekly to several members so they can follow along with the service that is broadcast on GRTV channel 25 on Sundays at 11:00 a.m. The DVD ministry also continues. We send DVD's of the 11:15 a.m. Traditional worship service to several members who do not have access to the cable channel.

<u>New Member Program:</u> In 2016, the new member program has seen some continuous improvement to meet the needs of the individuals and families who are finding a church home at Trinity. We had 39 new households join Trinity in 2016, which breaks down to 60 adults and 26 children.



**Poinsettia Delivery**: During the Christmas season, we share the holidays with our homebound/shut-in members, some of our elderly Trinity friends with the gift of a poinsettia. This year we had 9 deliverers take a total of 50 poinsettias to our members and friends. These were a wonderful reminder to our members and friends that they are missed and thought of by their Trinity family. This was also the second year that members who lost loved ones where included in the deliveries this year. Once again the Tuesday morning quilters provided quilts for many of the Poinsettia receivers.

<u>Prayer Ministry:</u> We continue to work towards expanding our electronic prayer chain. The monthly prayer group meeting that met once a month had some interest in the beginning but did not really catch on. The day and time seemed to not be the best choice for this initiative. The Prayer request form on Trinity's website has been used.





The Prayer Tree was a wonderful success. Our year end party was attended by almost 70 of the pray-ers and prayees. The second year of the Prayer Tree began with an increase of young people 0-18 being prayed for. We had 108 children signed up. This year one of our continuous improvements was to have children group in sibling groups and individuals. This was done in order to make sure no child fell through the cracks.



<u>Start of Summer Celebration:</u> Our annual summer kickoff event was great for all who attended. We actually were able to have the event outside. We also had Java Blue play one last time before Trinity Members Tom and Peggy Demmon moved to Dexter, MI. Next year's event will be on Wednesday, June 21, 2017. It is exciting to be collaborating with James Morin, Trinity's new Family Activity Coordinator.








#### Medicare Consultation with Trinity Member Jo Murphy, Executive Director of Michigan Medicare

#### **Health Advisory Committee (HAC)**

The vision of the Health Advisory Committee at Trinity Lutheran Church is to share God's gifts of love and grace to promote spiritual, physical, and emotional wellbeing.

Blood drives held in March, July (22 pints) and November (15 pints)

coordinated by Sue Babin. Number of pints decreased with fewer sign ups and donors turned away due to low iron count.

Flu Clinic was held in October with 52 participants receiving vaccinations.

Planning for "Healthy Trinity" was started in January. Healthy Trinity will be implemented beginning April 2017.

The HAC met 8 times this year (1/5, 1/19, 3/8, 4/11, 5/3, 9/28, 10/26 & 11/30)

Thank you to the HAC for the wonderful work that was done while Linda (Parish Nurse) was recuperating from surgery.

#### Parish Nurse

Linda was on medical leave from March 16 through June 1st.

Contacts were made in January and June through December.

Approximately 350 contacts include: phone calls, notes/cards; hospital, nursing/rehab, home visits; homebound/ private communion, office visits, and referrals from Pastoral Staff as well as referrals to resource agencies and Stephen Ministry.

CPR and First Aid classes were provided for staff in January.

Three new First Aid Kits were purchased and placed in easily accessible areas to better meet first aid needs. These kits are OSHA approved and meet ANSIZ308.1-2015 standards. (These standards are the minimum requirements for workplace First Aid Kits and minimum contents required.)

Calvin College junior nursing students visited on 2 separate occasions to learn about the role of Parish Nursing here at Trinity.

Attended 2 meetings of Grand Rapids Health Ministry Consortium (GRHMC).

Attended Exploring "Complicated" Mourning: Sudden Death and Trauma Loss presented by Alan D. Wolfelt, PH.D. on August 5<sup>th</sup>. This excellent event was sponsored by the Greater Grand Rapids End of Life Coalition at GVSU Eberhard Center.

#### **Stephen Ministry**

"Bear one another's burdens, and in this way you will fulfill the law of Christ (Galatians 6:2, NRSV).

Some interesting facts about Stephen Ministry:

Since Stephen Ministry was founded in 1975:

More than 12,000 congregations have enrolled in the Stephen Series.

More than 70,000 pastors and lay leaders from those congregations have been equipped at Leader's Training Courses.

More than 600,000 laypeople have received Stephen Minister training.

More than one-and-a-half-million people have had a Stephen Minister to walk with them, providing one-to-one Christian care during tough times.

Stephen Ministry is confidential, Christ-centered care for people who are *experiencing* life's challenges. After 50 hours of training, a Stephen Minister meets one-to-one with a care receiver on a weekly basis to listen, care, encourage, and provide emotional and spiritual support.

In 2016, we had 14 active Stephen Ministers who have met with and provided Christian care and support to 14 care receivers. As some Stephen Ministers have become inactive or have moved away, we have the need to train additional Stephen Ministers.

In preparation for that training, two Stephen Ministers, Beth Vanderwall and Sue Coates, attended the Stephen Ministry Leadership training January 8-14, 2017 in Orlando. Plans are being made now for a training class in the Spring!

As always, I thank all who have heard and heeded God's call to become Stephen Ministers and Leaders. I am grateful to care receivers who have accepted the care and support of Stephen Ministers. I thank the pastors, council and congregation for the support and prayers for Stephen Ministry. Every day, I thank God for this and all ministries at Trinity Lutheran Church.

### Review of Reports - Human Resources Committee, 2016

The Human Resource Committee is in our third year as a resource to Pastor Linstrom and the staff of TLC. Our members continue to share a wealth of knowledge and compassion when advising on staff related initiatives. The cycle of staff reviews and setting of goals and objectives, with each member of the TLC staff, took place in 2016. The HR Committee has in turn reached out to member of the staff to listen to any concerns they may have about their role at Trinity.

With the departure of Tim Van Der Bilt, our Children's Ministry Director, a new specialized team of six part-time staff devoted to the Youth and Family Ministry was assembled to address needs within that program. These positions include Brittany Fischer as Children's Ministry Coordinator; Rachele Battreall as Director of Youth and Family Ministry; James Morin as Family Activity Coordinator; Ashlee Wetherington as High School Ministry Coordinator (and part time Finance Assistant); Taylor Sytsma as Middle School Ministry Coordinator and Awilda Diaz as Nursery Coordinator. With the addition of new roles and new staff, we are focused on finalizing new job descriptions and revising others.

We would like to say a special thanks to Dawn Brackman for her professional services - providing Trinity Lutheran Church with advice and navigation through the Fair Labor Standards Act of 2016.

Trinity's Outreach Team focuses on providing opportunities for our members to help address unmet basic needs both locally and globally. This is accomplished through monetary donations, the collection of tangible items, and through the giving of Trinity members' time and spiritual gifts. All members are encouraged to select activities to which they feel called to participate.

Local issues are addressed through many Grand Rapids area organizations including, but not limited to:

- ~Dégagé Trinity provides regular teams of volunteer food servers and also has available for purchase \$2 Panhandler Vouchers.
- ~Family Promise/Interfaith Hospitality Network (IHN) Trinity continues to provide shelter, meals, and hospitality for homeless families on site on a quarterly basis for a week at a time. Trinity did host one group of families for a two week period in 2016 when the church following Trinity in the IHN rotation was unable to host. We pray that more Trinity members will become involved in this vital ministry.
- ~Feeding America West Michigan Members are encouraged to participate in bulk food repackaging.
- ~God's Kitchen Trinity provides a regular team of volunteer food servers.
- ~Habitat for Humanity Trinity members again worked on a Habitat build in Grand Rapids, as they have done for several years.
- ~SECOM Trinity members provide Thanksgiving and Christmas baskets through SECOM. 2016 also included a tour of the facility and operations by the Outreach Team.
- ~Various local food pantries Trinity supports pantries through ongoing food collection in the grocery cart near the kitchen and through the Souper Bowl Sunday collection.
- ~Trinity families also donate cleaning supplies, personal care items, new under clothing and diapers, school supplies, bus tickets, coats and blankets, and items for local charities' "Christmas Stores" during the year.
- Please visit the Trinity website at tlcgr.org Outreach tab for a full list of organizations we support.

In 2016, Trinity also stepped up to lend support during the Flint Water Crisis, sending donations two times during the year to Salem Lutheran Church for replacement of lead water pipes and installation of a filtration system to serve as a safe water source for the community.

A partnership with Congress Elementary was a new venture for Trinity in 2016, and Trinity members have been very generous in donating a cargo van load of school supplies, snacks, hand sanitizers and sanitizing wipes. Trinity members also volunteer at Congress as reading tutors through the Schools of Hope program and as meal providers for teachers during parent-teacher conferences. A \$1500 grant from the Synod's Publicly Engaged Church will go to support activities at Congress Elementary as well.

God's Work Our Hands Sunday fell on September 11 in 2016, so we honored first responders in our community by inviting and specially recognizing them in our worship services on September 11 and by completing the following projects at their requests: 125 "On the Go" snack bags filled for American Medical Response; new kitchen countertops installed at GRFD Station #11; a new wheelchair ramp was evaluated and planned by Trinity members for installation at a Life EMS client's home, but was not ultimately installed by Trinity due to another community organization meeting the need.

A Mission Interpreter event to encourage Trinity members to learn how we can "tell the story" of the many ways the ELCA does God's work was scheduled for December 11, but was canceled due to poor weather. Look for a rescheduling of this event in 2017 when Bill Duggan from the Synod will join us to speak about this simple but very important ministry.

Global issues are addressed through the work of ELCA World Hunger and ELCA Disaster Response. Trinity also has members who are active in meeting global needs through LWR Quilts, Operation Christmas Child, Neerekshe India Mission, and the Honduras Synod Team.

The most significant focus of the Property Committee over the last 12 months, in addition to addressing the regular repair and operational needs of our facility, was to undertake the planned repairs of the cross tower. This was deemed 'urgent' in light of significant stone cracks, breaks and several large stone pieces falling from the structure last winter. Bids were received for the repairs and a contract was awarded in late April 2016. Work was begun shortly thereafter and progressed steadily throughout the summer and fall months. Several unexpected structural concerns were identified and repaired. These added significantly to the project cost and were deemed necessary before further work could go on. As of this writing, the tower repair contractor continues to await delivery of stone from the quarry. Once the replacement stone is received the tower is expected to be completed within a 4-6 week period, weather permitting.

As we all anticipate the launch of a major building project, hopefully in 2017, building modifications and repairs have been weighed against the goal of deferring them as much as possible for 'the big project'. Thus roof issues, HVAC, electrical and general maintenance have been delayed if possible and reasonable. Unfortunately, the committee was pressed to address: major boiler control repairs this past spring and summer; several roof leaks and subsequent ceiling repairs, and an AC failure in one of the offices.

Recent Property Committee efforts have been directed to: wall repairs and painting in the sanctuary; carpet cleaning; installation of a shower in the family bathroom downstairs, and a washer and dryer in the fellowship wing as requested by the IHN/Family Promise team. Also, a tree removal plan has been implemented to address dead and dying trees and to improve the western portion of the property. This has in part been completed with volunteer labor. The Property Committee recognizes the significant time, labor and plantings by our Volunteer Gardeners in our numerous flower beds.

The Property Committee has been served over this past year by: Jim Coates- Council Liaison, Gene Gunderson- Council Liaison, Niki Ferguson-Facility Sexton, Mark Johnson, Myron Pearson, Dale Barkema, Dan Workman, Fran Anderson, Dave Mester, Fred Wilcox, Bob Heine, Roger Marks, Bill Bruin and Frank Remsburg, Chairman. We are blessed to have this dedicated and committed group working to keep our church and grounds in the best condition possible.

Think of us in this way, as servants of Christ and stewards of God's mysteries. Moreover, it is required of stewards that they be found trustworthy.

1 Corinthians 4:1-2

As you gather, the following questions are frequently asked about giving and the work of the church. These may be helpful as your congregation engages in conversation about how to grow and thrive in the future.

#### What is missional giving?

One way individuals and congregations participate in missional giving is when their financial contributions, often called offerings or tithes, to and through their congregation, or other charitable organizations, are intended to do God's work in the world. We believe this work can be done faithfully through ELCA ministries.

#### Why give?

For some the answer is God first gave to us, thus through our life we have an opportunity to share God's generosity with others. This understanding demonstrates giving is a spiritual issue, not a financial one. For other Lutherans, the answer is also an identity issue. We are faithful Lutherans and this is what we do — share with others. This is not an individual experience only, for we are church together, and through our unified giving we do God's work.

#### Who gives?

All are invited to give as God has blessed them and as the Spirit moves them.

#### What to give?

As the apostle Paul wrote of the Christians in Macedonia, "They first gave themselves to the Lord." Through baptism, confirmation and our confessional statements, each person first gives of themselves to God. Within each person's faith walk, they are asked to give of their time, talents and resources. This can take many forms.

#### How much to give?

We teach to grow toward a tithe (10 percent of household income), to a tithe and beyond a tithe as God has blessed you. This may also apply to one's time.

#### When to give?

Individuals and congregations are encouraged to give regularly. The practice of "first fruits" giving, sharing a portion of God's blessings when they are received, is encouraged. This may be weekly, monthly or quarterly. There are also times for special giving. This is often in response to specific needs or opportunities. There are also times for planned gifts. This is often for major projects or at the end of life. All these forms of giving are encouraged.

#### Where to give?

Most supporters of the ELCA do the majority of their giving to and through their congregation. When growing toward and beyond a tithe, giving to all charitable organizations is considered.

#### How to give?

All regular giving received by ELCA congregations is considered undesignated. This means the dollars received can be used as determined by a missional budget or expense plan approved by a quorum of the membership and as managed by elected leaders. An increasing percentage of total giving to congregations is being designated for specific purposes. While we appreciate and celebrate all giving and respect the wishes of the donor, we also trust members and elected leaders to make financial decisions that support God's work in and beyond the local community, both in the present and for the future.

#### What is Mission Support?

This is the portion of your congregation's regular financial offering that is shared with your synod. The synod then shares a percentage for God's work that we do together through our ELCA churchwide organizations, both domestically and globally.
